Mayor Bennett called the meeting to order at 7:10 P.M. On a motion by Mayor Wasowicz and seconded by Mayor Finnegan the October 30th, 2024 Meeting Minutes were approved.

Guest Speakers

Tim Gainer, FORTRESS Plus Solutions, presented information about his company and how they have the ability to properly secure and store many items that municipalities have to securely store for various reasons.

Danny Walker, Toni Garza, Luke Burrows and Adriana Carrasquillo of ComEd gave an overview of ComEd's Energy Efficiency Program including municipal matters, small business matters as well as residential matters.

President's Report

Mayor Bennett congratulated President Ryan for being selected to serve on the IML Board of Directors and he congratulated Mayor Straz for being selected to serve on the MMC Board. He thanked all Mayors for their service and commitment to the SCM.

Executive Director's Report

Ms. Smith Thanked everyone who participated in the SCM's June 18th golf outing. Thank you to the many sponsors – we appreciate it. She noted that the SCM is already working on next year's golf outing and once the details are confirmed we will let you know. We are considering having only one course - but that has not been decided yet. The last few years we've had a difficulty filling both courses while having to pay for both courses. Thank you to everyone who attended the Newly Elected Officials Workshop on Saturday, June 14th. Ms. Smith noted that she hopes everyone found the workshop to be useful. The SCM hopes to offer more training in the future as a joint effort with other COGs. Ms. Smith noted that the SCM will hold their Joint Municipal Auction on Saturday October 4th at Palos Hills Public Works Facility. The following municipalities are participating in the auction: Evergreen Park, Burbank, Hickory Hills, Chicago Ridge, Bedford Park and Palos Hills. Ms. Smith asked everyone to submit their Membership Directory information as soon as possible. Ms. Smith noted that the SCM is a member of the Pension Fairness for Illinois Communities Coalition and that she will be sending information that the municipalities can use on their social media accounts as well when they contact your legislators. Ms. Smith noted that the SCM partner with DMMC, NWMC, SSMMA, and LCML to send a letter to the Governor regarding the transit issue. Knowing that transit reform needs to take place in Illinois in order for it to remain vital these are the items that our letter addressed: Governance and Representation; Local authority and Transit-Oriented Development; Transit Funding and our Commitment to Collaboration. The SCM will continue to monitor the transit issue and participate when and where we can. Ms. Smith reminded everyone of Pathlights' 500 for 50 Campaign and encouraged everyone to make a donation.

Committee Reports

Transportation Committee/Local STP Report

Ms. Matyas reported that Quarterly STP Projects reports are due. Ms. Matyas also noted that the SCM will be having a call for new STP projects in October.

On a motion by Mayor Milovich-Walters and seconded by Mayor Finnegan the Southwest Conference of Mayors' updated STP Methodology was approved.

On a motion by Mayor Straz and a second by Mayor Wasowicz a cost increase for Lemont's Phase I Engineering for the 131st Street project was approved.

Mayor Bennett noted that the MMC's Legislative Committee met to discuss the transit issue in Illinois and it was decided that the MMC would not take an official position because there was not consensus among its Members. For this reason the SCM participated with other COGs to send a letter to the Governor as noted in the Executive Director's Report.

Utilities Committee Report

Ms. Adriana Carrasquillo, ComEd, noted that ComEd will be sending out the municipal surveys in two years. She thanked everyone for their attention during their presentation.

Public Works Committee

Ms. Matyas reported that the SCM Public Works Committee will met next on November 11th.

Cal Sag Watershed Planning Council Report

Ms. Smith noted that the next meeting for the Cal Sag Watershed Planning Council will meet next on September 29th, 2025 at the Village of Palos Park.

Other Business

MVCC Update

Mayor Bennett congratulated Mr. Pappageorge on becoming a Vice President at MVCC. Mr. Steve Pappageorge gave a brief update on the happenings at MVCC and he noted that enrollment is up about 3%. The southwest Education center is in the process of being updated and will become a Healthcare Professions facility.

Pathlights

Ms. Alison Parker gave an update on the happenings of Pathlights including programs and encouraged everyone to participate in Pathlights' 500 in 50 Campaign. They are hoping to raise \$25,000 by October 25th.

CSCVB Update

Ms. Mary Patchin and Ms. Kim Kislowski gave an update on the happenings of the CSCVB.

Mayor Bennett thanked his staff for preparing for and hosting the meeting tonight.
